



# Limited Lifetime Leak Proof Warranty

**THE DURATION OF THIS WARRANTY BEGINS ON THE DATE OF PURCHASE BY THE CUSTOMER AND EXTENDS FOR THE LIFETIME OF THE PRODUCT AND KENNEDY SKYLIGHTS ACCESSORY PRODUCTS SOLD BY KENNEDY SKYLIGHTS TO THE ORIGINAL PURCHASER OF THE PRODUCT.**

This Warranty applies to the original installation of the following **KENNEDY SKYLIGHTS** models installed on residential buildings, with the proper Step Flashing, one layer of properly installed roofing material, which are identifiable by the product code and size designations:

## **DECK MOUNTED SKYLIGHTS**

**TSFG2** skylights and related flashings

**LSFG2** skylights and related flashings

**TSVG4** (manual, electric and solar) skylights and related flashings

**LSVG4** (manual, electric and solar) skylights and related flashings

Flashing kit **DMSF** Installed according to our instructions and pitch requirements

## **CURB MOUNTED SKYLIGHTS**

**TCMG** skylights and related flashings

**LCMG** skylights and related flashings

Flashing kit **CMSF** Installed according to our instructions and pitch requirements

**This warranty is separate from, and in addition to, KENNEDY SKYLIGHTS' limited lifetime warranty on Products.**

For a limited lifetime **KENNEDY SKYLIGHTS** warrants that no water will leak through the installed Product or between the installed Product and the roof deck, provided that the Product is installed strictly in accordance with **KENNEDY SKYLIGHTS** deck or curb mounted skylight and related flashing installation instructions.

If there is any water leakage through the installed Product or between the installed Product and the roof deck **KENNEDY SKYLIGHTS** will at its option, (a) repair the product, or (b) provide a replacement Product (or part, as appropriate) of like kind and design.

If **KENNEDY SKYLIGHTS** elects to provide a replacement Product, the limited warranty on the replacement will last only for the balance of the original Product warranty period. If the Customer fails to provide satisfactory proof of the date of purchase, the date of manufacture shall be used instead.

**KENNEDY SKYLIGHTS'** liability under this warranty is limited to either (a) or (b) above, and **KENNEDY SKYLIGHTS** will not be responsible in any event for shipping, labor, removal of original product, installation, and expenses, or other charges claimed or incurred by Customer.

If the date of original purchase cannot be established, the warranty period shall be deemed to begin on the date of manufacture as indicated on the Product. Any reinstallation or replacement of a Product shall not extend the original warranty period provided herein.

(a) original purchaser means the natural or legal entity or person who owns the product and has not acquired it with a view to reselling or installing it in the course of a business.
